Methods and material for containment and cleaning up:	Advice on how to contain a spill: Covering of drains.  Advice on how to clean up a spill: Wipe up with absorbent material (e.g. cloth, fleece). Collect spillage: sawdust, kieselgur (diatomite), sand, universal binder.  Appropriate containment techniques: Use of adsorbent materials.  Other information relating to spills and releases: Place in appropriate containers for disposal. Ventilate affected area.
